

















#### Stockyard Inspections

- Proper tags
- Sheep, goat, cattle processing and sale preparations
- Cattle pregnancy check





**Scrapie** is a deadly degenerative illness that affects sheep and goats' central nerve systems. It's one of a group of illnesses known as transmissible spongiform encephalopathies (TSE). Infected flocks can lose a lot of weight and produce less.

**Tuberculosis (TB)** is a chronic disease which, in sheep and goats, can be caused by mycobacterium bovis or mycobacterium tuberculosis.


